ST. REGIS AKWESASNE BAND OF INDIANS
BY-LAW NO. 10(b)-84

A By-Law to amend By-Law No. 10(a)-73 Detailing Traffic Regulations for the St. Regis Akwesasne Reserve

WHEREAS paragraphs (b) and (r) of Section 81 of the Indian Act empower the Council of an Indian Band to make by-laws respecting the Regulation of Traffic and the imposition of a fine for violation of any by-law made under that section;

AND WHEREAS the Council of the St. Regis Akwesasne Band of Indians did enact By-Law No. 10(a)-73 respecting the Regulation of

AND WHEREAS the said Council deems it to be expedient and in the best interest of the residents of the St. Regis Akwesasne Reserve to amend the said by-law;

NOW THEREFORE the Council of the St. Regis Akwesasne Band of Indians enacts as a by-law thereof as follows:

- Section 1(c) of By-Law No. 10(a)-73 be and the same is hereby now recognized as No. 4 so that the said Section shall read:
 - 4. That these regulations apply to all roads, streets, lanes or other places open to the public for the passage of vehicles.
- Section 4 of By-Law No. 10(a)-73 be and the same is hereby deleted and replaced by the following definition of "motor vehicle" and now recognized as No. 1(c) so that the said Section shall read;
 - "motor vehicles" includes an automobile, motor-cycle, motor assisted bicycle unless otherwise indicated in this by-law, and any other vehicle propelled or driven otherwise than by muscular power, but does not include the cars of electric or steam railways, or other motor vehicles running only upon rails, or a motorized snow vehicle, traction engine, farm tractor, self-propelled implement of husbandry or road-building machine.
- 3. Section 8(b) of By-Law No. 10(a)-73 be and the same is hereby amended by deleting the words "fifty dollars (\$50.00)" in (a) and inserting the words "\$100.00 minimum to \$500.00 maximum and a possible term suspension of drivers licence" so that the said Section shall read;
 - (a) to a fine of \$100.00 minimum to \$500.00 maximum and a possible term suspension of drivers licence for the first offence.

By deleting the words "One hundred dollars (100.00) in (b) and inserting the words "\$500.00 minimum to \$1,000.00 maximum or imprisonment of six months or both fine and imprisonment" so that the said section shall read;

(b) to a fine of \$500.00 minimum to \$1,000.00 maximum or imprisonment of six months or both fine and imprisonment for the second offence.

By deleting the words "One hundred dollars (\$100.00) and to imprisonment for thirty days" in (c) and inserting the words "\$1,000.00 and imprisonment of no less than one year but no more than two years and revocation of drivers licence" so that the said Section shall read;

(c) to a fine of \$1 000.00 and imprisonment of no less than one year but no more than two years and revocation of drivers licence for the third subsequent offence.
